## TERMS AND CONDITIONS

- Only **CropBooster OP** and/or **RR SoyBooster OP** are eligible for this performance guarantee program;
  - CropBooster OP** and/or **RR SoyBooster OP** must be applied in accordance with label recommendations;
  - To register for the **CropBooster OP/RR SoyBooster OP** guarantee program, grower must complete this registration form and submit it by email to [orderdesk@agro-100.com](mailto:orderdesk@agro-100.com) on or before the **second Friday of May of the year the crop is sown for wheat acres, and on or before the second Friday of June of the year the crop is sown for corn and soybean acres** (in case of weather related delays, registration forms may be accepted at a later date but at the sole discretion of **Agro-100**);
  - The **CropBooster OP/RR SoyBooster OP** guarantee does not apply to any product returned for any reason whatsoever or to any product purchased for resale, or to any product purchased but not applied;
  - The **CropBooster OP/RR SoyBooster OP** guarantee covers only the replacement of the **CropBooster OP** and/or **RR SoyBooster OP** purchased;
  - The **CropBooster OP/RR SoyBooster OP** guarantee shall be limited to 250 total acres per grower;
  - The **CropBooster OP/RR SoyBooster OP** guarantee is available for on-farm use only;
  - To substantiate yield performance, grower must:
    - leave a **representative check strip in each treated field**
    - conduct a side-by-side weigh off**
    - document the results of the weigh off**, and
    - have the results signed by the grower and one independent person capable of certifying the weigh off.** **Agro-100** or their representative(s) may attend the weigh off if so requested by **Agro-100** or grower. Weigh off data shall be provided to **Agro-100** as requested, subject to grower's consent.
- CropBooster OP** and/or **RR SoyBooster OP** are designed to be used in tank mixture with herbicides. Herbicides (at recommended label rates) accepted for this performance guarantee program are:
- CORN: CropBooster OP** + all post-emergence herbicides alone or combinations of post-emergence herbicides with or without glyphosate applied before V6 growth stage.
- SOYBEANS: RR SoyBooster OP** + all post-emergence herbicides alone or combinations of post-emergence herbicides with or without glyphosate applied before R1 growth stage.
- WHEAT: CropBooster OP** + all post-emergence herbicides alone or combinations of post-emergence herbicides applied before flag leaf (T2) growth stage.
- NOTICE:** Because Bayer has published the following statement "Do not use ammonium sulfate (AMS) and ammonium based additives, adjuvants, or sprayable fluid fertilizers when applications include XtendiMax herbicide" the **Agro-100** Guaranteed performance program is not applicable to XtendiMax herbicide.
- Always check the compatibility of the tank mixture using a jar test with proportionate amounts of product to be used and the water to be used before mixing in the spray tank. **Agro-100** assumes no risk or liability for claims associated with tank mixtures.
- Any claim alleging yields having a value less than the purchase cost of **CropBooster OP** and/or **RR SoyBooster OP** applied must be received by **Agro-100** on or before the **last Friday of November of the year the crop is sown**. Claims must be supported by the above-mentioned side-by-side weigh off documentation (**all completed registration forms, claims and side-by-side weigh off documentation received after this date will be considered null and void**);
  - Agro-100** reserves the right to verify the information provided and reserves the right to modify or withdraw any or all of the terms of the grower program if required by law or for any other reason at the sole discretion of **Agro-100**. Any of such terms are void if prohibited by law.
